5. QUESTIONS FROM MEMBERS OF THE PUBLIC

i.) Question from M Holland

How will the Council ensure that they meet their duty to pedestrians, including visually impaired pedestrians, both in the consultation process and the considerations for the new Public Realm Strategy design?

Response by the Town Mayor Clir Mrs E Wardlaw

To answer the question on the Public Realm Strategy in regard to duty of care for pedestrians, including visually impaired pedestrians, the scheme will be subject to independent Safety Audit checking at a number of stages in the design and implementation process. The concept, which will inform the final design, includes using high colour contrast kerbing materials, kerbing where essential, and the retention of the pedestrian crossing on Market Street.

CEC are working closely with the Public Realm Sub Committee of Congleton Town Council and we will also consult with Guide Dogs for the Blind and a local disability group in the consultation phase of the scheme. There will also be a Public Consultation phase for the scheme where residents, businesses and visitors in Congleton will be able to give their feedback.

Feedback from the consultation phase and safety auditing informs and shapes the scheme ahead of detailed design and construction.

I hope this response answers the questions adequately at this stage, but please be aware that the Town Council is not project managing this scheme, nor are we experts in the needs of the visually impaired, this role is being undertaken by the Highways Authority which is Cheshire East Council.

Marilyn Holland enquired whether the pedestrian crossing would be maintained in Market Street and commented that visually impaired can't get about without having kerbs as a reference point.

ii.) Question from Bill Keeling

What action is being taken against Councillor P Broom for the comments he made at the Personnel Committee meeting in October 2015 against Councillor Mrs D S Allen?

Response by the Town Mayor Cllr Mrs E Wardlaw

Thank you for the question, the matter you have raised is being dealt with through the Councils' Complaints Procedure, its finding will be forwarded to the relevant individuals and will be subject to the Data Protection Act of 1998.
