Town Hall 150 Year Celebration Update

Purpose of this paper

To note updates from the Town Hall 150 year celebrations committee.

- 1. Flower Plaque for the Park. This has been designed by the Town Council's Streetscape section and will be planted out in June.
- 2. Mass Participation Card Stunt following discussions with the schools this will now take place on Wednesday 15th June in Congleton Park/Hankinson's field from 1.30pm 3pm. Currently investigating whether it could be a potential Guinness World Record.
- 3. Victorian Civic Celebration 'Tea party' Sunday 10th July 5-8pm also a chance to preview the Living History exhibition
- 4. Schools Living History Exhibition Monday 11 Wednesday 13 July exciting plans to give Congleton school children a chance to see what their lives would have been like if they'd been born 150 years earlier.
- 5. Plaques and decorating the front of the Town Hall see appendix 1. As discussed at previous committee the group has been developing the ideas around the plaques and decorating the front of the Town Hall generally to make it look extra magnificent for these celebrations but in line with what is allowed on a listed building. Town Hall Prices and Terms and Conditions

Purpose of this paper

In readiness for the start of the new financial year Town Hall staff have spent some time reviewing Congleton town hall prices and checking our prices against similar venues. This exercise was also carried out last year. Staff have also taken this opportunity to review our prices, offers, terms and conditions to see if any improvements can be made. A copy of the 2015/2016 current pricing structure is attached as Appendix one along with the proposed changes which are highlighted in red.

General Prices

The Town Council is still competitively priced when compared with other venues, and we believe there's no justification to increase prices at this time. Office staff ran a comparison on similar sized local venues using the current published pricelist for a full day wedding, evening party and charity event. Congleton town hall was a mid-priced venue, working out the second cheapest for a full day weekend wedding, and thanks to the generous 50% concessional grant for community groups, the cheapest for weekend concerts.

The week-day business booking offers giving reduced rates for half-day and full-day business rates are proving popular. (Four hours for the price of three, or eight hours for the price of five). We would like to retain these for 2016/17 but to remove the word "business" so that it's clear that community groups, local charities and individuals can also benefit from these rates, where they are more beneficial than the 20% charity concessional grant or 10% residential concessional grant. If claiming the reduced week-day half or full day rates, further concessional grants would not apply. The Town Council makes a budget provision for £4000 worth of Town Hall booking concessional grants per year. So far in 2015/16 £2,026 has been claimed, so there is scope to increase the offer beyond businesses.

Evening Rates

Currently the price list does not give any evening prices apart from the Friday and Saturday evening price for the Grand Hall. This entitles the customer to use the Hall from 3pm – 1am for £320 plus VAT. The office has been charging the standard hourly day rate for evening bookings in the week. This needs to be clarified on the price list. Friday and Saturday evenings are treated as a premium which is why we don't allow two hourly bookings for these evenings. This is in line with most other town halls.

Evening Rates continued...

We would like to offer the £320 + VAT evening rate as an option for weekday bookings, with use of the Hall from 3pm – 1am. We would also like to trial offering the half-day and full – day reduced rates for evening bookings (excluding Friday and Saturday evenings). This could be marketed for July – October 2016 and the results reported back. The cost of the success from this offer would be met from the funds allocated in the grants budget towards subsidised use of the Town Hall.

Charitable Grants for Town Hall Use

Congleton Town Council currently considers concessional grants to local registered charities and other voluntary/community groups where they provide a direct benefit to the Town.

- 20% concessional grant towards the standard room booking rate for weekdays and weekday evenings
- 20% concessional grant towards the standard room booking rate for weekends between 8am and 3pm.
- 50% concessional grant towards the Friday and Saturday evening rate between 3pm and 1am.
- 10% CW12 residents' concessional grant towards the standard room rate when booking for a private function.

The Town Council has awarded room hire concessional grants of £2,026 to date in 2015/2016 against a budgeted figure of £4,000 meaning that with the proposed budget staying the same there is scope to extend the offer.

If the weekday evening £320 + VAT offer is extended to weekday bookings, we believe it would make sense to extend the 50% local charity concessional grant for this type of booking. It would also make sense to adjust this to encourage use during our quieter times by reducing the weekend concession to a 40% concessional grant and increasing the weekday evening grant to a 60% concessional grant.

This would increase the Friday and Saturday price paid for the Grand Hall for use between 3pm – 1am by local charity groups on a Friday and Saturday evening from £160 plus VAT (£192 total) to £192 plus VAT (£230.40 total) . It would also give them an option for a weekday booking for £128 plus vat (£153.60) – the current evening cost with their 20% concessional grant would be £290 plus VAT.

Supporting Health, Well-being and Social Inclusion

Members may wish to consider taking this opportunity to amend the pricing policy to reflect Goal 1 of the Town Council's Corporate Business Strategy:

GOAL 1: AN ACTIVE AND ENGAGED COMMUNITY

- 1. To support, develop and empower the community & voluntary sector
- 2. To promote community cohesion
- 3. To promote health and fitness amongst our residents and workforce
- 4. To engage with the Town's present and future generations

An example would be to offer Sunday – Thursday concessionary grants to groups or individuals organising events which are directly aimed at promoting health and fitness. This would need to be in the form of dance or exercise classes with a qualified instructor.

Weddings

These were considered in detail in March 2015 and again during the recent price comparison exercise, we do not believe there is any justification to increase the price of wedding bookings at this time.

Booking Terms and Conditions

These need to be amended to reflect best practice and the name of the new Commercial Partner.

Recommendations

The Town Hall Committee is asked to approve the following changes to the Town Hall Pricing Policy

- 1. In general Congleton Town Hall prices remain the same for 2016/2017
- 2. The pricing sheet is amended to include evening hourly rates the same rate as the daytime rates
- 3. The business half-day and full-day offers continue for 2016/2017 but the wording amended to open the offer to groups, organisations and individuals not just businesses.
- 4. The half-day and full-day offers can be applied to Sunday Thursday evening bookings as a trial for July October 2016 inclusive. This will be reviewed after four months to check the success rate. Groups and individuals taking advantage of this offer will not be entitled to additional concessional grants.
- 5. The Friday and Saturday evening event rate can be offered on weekdays with use of the Grand Hall between 3pm 1am for £320 + VAT.

- 6. Local charities booking the £320 + VAT offer on Friday or Saturday night currently apply for a 50% concessional grant. The grant for Fridays and Saturday evenings be reduced to a 40% concessional grant, while the concessional grant on the £320 + VAT offer on Sunday Thursday would be introduced and offered at a 60% concessional grant.
- 7. During the proposed promotional period of July-October 2016, discretion may be given to the definition of local charity groups and organisations to enable qualified instructors/professionals aimed at improving physical health and well-being or reducing social isolation from those most in need to be able to benefit from the charities discount.
- 8. Delegated powers to the Chief Officer and office staff involved with the Town Hall management, to update the booking terms and conditions in consultation with the Chairman and Vice Chairman to include details of the new Commercial Partner and to reflect best practice with regards to insurance, risk and security.
