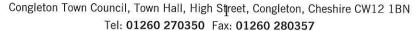

Cheshire East Local Plan Strategy - April 2016

Congleton Town Council wishes to make the following representations to the Proposed Changes to the Cheshire East Local Plan and to appear at the forthcoming Examination in respect of the following matters;

- 1. The Summary of Site Recommendations
- 2. Section of the Plan which deals with the Strategic Sites in and around Congleton
- 1. The Summary of Site Recommendations.

Paragraph 12.13 on page 13 of the Local Plan states 'The Spatial Distribution proposes that 4,150 homes be provided in Congleton alongside 24ha of Employment land'.

This is technically incorrect as the majority of this new development will be provided to the north of and outside the boundary of the town in the adjoining Parishes of Somerford, Eaton and Hulme Walfield. The description of the area in the Local Plan should be consistent and in this opening section it should refer to '4,150 homes and 24ha of Employment land being provided in and around Congleton principally on land to the north of the town in the Parishes of Somerford, Eaton and Hulme Walfield.'

2. Strategic Sites in and around Congleton

Of more concern to the Town Council is the lack of an overarching strategic policy for the release of the land to the north of the town, the delivery of the link road, community facilities and associated open space based up on the North Congleton Masterplan produced by Barton Wilmore for Cheshire East Council.

The Local Plan in paragraph 15.225 (page 366) identifies a number of Strategic Sites in and around Congleton. Paragraph 15.230 (page 368) refers to the North Congleton Masterplan and highlights particular sites at Back lane and Radnor Park; Congleton Business Park; Giantswood Lane to Manchester Road; Giantswood Lane south and; Manchester Road to Macclesfield Road. The Local Plan then goes on to discuss each of these sites in detail however there is no overarching strategic policy for the whole of the North Congleton Area related to the North Congleton Masterplan setting out the timing and delivery of infrastructure, any equalisation payments, Section 106 or CIL contributions to the Link Road, delivery of cycleway and footpath networks and other community facilities and open space and, how this new development area will link into and relate to the town.

The retention of employment within the town and the ability of local firms and new businesses to expand and locate is crucial to the future prosperity of the area. In order to retain the existing job density within the town a minimum of 26ha of new employment land is required. Utilising Cheshire East Council's revised job density figures in the Proposed Changes to the Local Plan 47ha of employment land will be required over the plan period. At the moment only24ha of new employment land is included in the development area to the north of the town. The Town Council would, as part of a Strategic Policy for this area, like to see the area of employment land in this area increased.

The Town Council is very concerned that there is no Strategic Policy for the Congleton Strategic Site and would suggest that Cheshire East should consider inserting a Strategic Policy in the Plan to deal with not only the comprehensive development of the area to the north of the town but also to ensure the timely delivery of the employment land, community infrastructure, open space and the Link Road.

Other specific areas of concern are:-

- 1. The Local Plan does not provide any allocation of land to enable the growth of the secondary schools
- 2. There is an area of land adjacent to the Back Lane Playing Fields (reference from Congleton Borough Local Plan DPS(C1)) that is being proposed for housing development. This was previously allocated for sports playing fields and there is strong evidence of local demand for this use.

Conclusion.

The first point is a matter of detail and consistency. The Town Council is of the opinion that the inclusion of a Strategic Policy for the whole of the North Congleton Development Area is fundamental to the future growth of this area. Such a policy would in our view not only strengthen the Local Plan but also assist in the timely delivery of the Link Road and the associated infrastructure to service such a large area of new development. It would also ensure that sufficient employment land was allocated to meet the future needs of existing and future employers in the town. In order to explain our case fully we would urge the Inspector to visit the town, to look in detail at the land to the north, the importance of the delivery of the link road in its entirety, the importance of the provision of employment land to allow the local economy to grow and how the new development area will relate to and link with the town.

We would like the opportunity to appear at the Examination to expand upon the points raised above.
