CONGLETON LINK ROAD - PROGRESS UPDATE - CIIr G S Williams

Progress December 2016 to August 2017

Following the publication of the Compulsory Purchase Order (CPO) and Side Roads Order (SRO) in October 2016, 23 objections were received during the objection period; a Public Inquiry was subsequently held at Congleton Town Hall in May 2017. Of the six remaining objections at the end of the inquiry, there was one substantive objection for consideration by the Inspector appointed by the Planning Inspectorate. The Inspector has submitted his recommendations to the Department for Transport who are currently considering it.

A minor non-material amendment to the approved planning application was submitted and approved in April 2017. This concerned an increase in the length of bund near Chelford Road and a minor change in the alignment of Back Lane.

Our designer, Jacobs, has prepared drawings and tender documents necessary for a contractor to be able to design and construct the scheme. A Contract Notice inviting expressions for interest in designing and building the scheme was published in Official Journal of the European Union in July 2017. Submissions were received in August 2017 and the Council is currently considering these. Environmental surveys have continued. These are necessary in order to obtain the necessary information to obtain European Protected Species Licences (EPSL) and have included extensive surveys of Great Crested Newts, Bats and Ancient Woodland.

We have continued to meet with landowners; in some cases, this has included discussions on minor design changes to meet individual needs and whether the Council could obtain land by agreement.

Work has continued on developing the business case for the scheme which has now been submitted in outline form to the Department for Transport (DfT) which is the main funder of the scheme.

We have held discussions with stakeholders such as the Environment Agency and utility companies concerning the building of the scheme.

Planned work for September 2017 to March 2018

We will continue to meet landowners who are affected by the link road with a view to address their particular requirements and to reach agreement for purchasing land by agreement. Work will continue to hold discussions with the Department for Transport regarding the business

Following changes agreed at the Public Inquiry it will be necessary to submit a revised planning application for a minor material amendment to the scheme; additionally, a separate application will be submitted in connection with Eaton Hall Quarry.

Environmental work will continue and European Protected Species Licences will be prepared. A further ground investigation is planned for Autumn 2017. The purpose of this is to be able to provide tenderers with more information about the groundwater in the vicinity of Chelford Road. Following the Inspector's recommendation, we expect the CPO and SRO to be confirmed by the DfT in Autumn 2017.

Tenders for the design and construction of the link road will be issued to prospective design and build contractors in September 2017 and should be returned in December 2017. These will be evaluated after which the final business case will be submitted around March 2018.

Dog fouling and control - a consistent approach across Cheshire East

We are considering introducing a Public Spaces Protection Order (PSPO) across the Cheshire East borough to help us tackle dog fouling and dog control more effectively. We know that most dog owners are responsible and we thank them for their continued support in helping to keep our public areas clean.

We are asking for your views on the proposed PSPO for dog fouling and control across Cheshire East.

Dog fouling and control PSPO survey.

This consultation will run for four weeks from 12 noon on Tuesday 12 September to 12 noon on Tuesday 10 October 2017.

Dog controls the PSPO would introduce
The PSPO would introduce two main requirements:

- to ban dog fouling in all public places; and
- to allow authorised officers to tell a dog owner/walker to put and keep their dog on a lead if necessary, For example, if their dog was showing aggressive behaviour.

Why we want to introduce a new PSPO for dog fouling and control

Cheshire East Council has a statutory duty to keep land clear of litter and refuse (including dog fouling) and a duty of care for dealing with waste. We have a duty to take action against irresponsible individuals who fail to clear up after their dogs on land which is open to the public. Dog mess is highly unpleasant and a hazard to health - particularly to children.

The introduction of a PSPO for the Cheshire East borough will replace and extend existing dog controls and byelaws. This will allow us to have a consistent approach to dog fouling as well as other dog control requirements to encourage responsible dog ownership and for everyone to enjoy our open and public spaces safely.

We are required to review PSPOs every three years - or sooner if necessary - if, for example, the community wanted us to give increased protection for dedicated areas such as enclosed children's play areas, cemeteries and repeat problem areas.

A newly introduced PSPO would link into our campaigns such as 'Dog Watch' and 'Keep Cheshire East Clean - No Rubbish Excuses' which seek to change

The proposed development is not being in keeping with the area.

This part of the housing estate was built on four green fields that had belonged to the Congleton Inclosure Trust, a local charity which was set up to administer the common land. In recent times it has been selling off land and using the proceeds to make grants to community projects. In order to ensure that its land was used for high-quality housing, the Inclosure Trust placed restrictive covenants on the plots to prevent building at too high a density. The restrictive covenant on the "Pegasus" plot allows only one dwelling on the site, with its design to be approved by the Inclosure Trust. The rest of the four fields were restricted to a maximum of 160 dwellings overall. Each of the four corner plots on the main road is occupied by a single bungalow.

The result of these covenants is clear if you walk round the estate. The scale is generous. Even 3-bedroom semi-detached houses each a wide window both upstairs and down. They have a double-width entrance, allowing a side-panel with windows beside the front door, replaced in many instances by a fancy porch. Each house has a garage, allowing a two-storey side extension to be built if required. In addition to parking space, they have well-kept front gardens, with beds beside the footpath. By contrast the houses proposed for the "Pegasus" site have windows only half as wide. The front entrance is just the width of one door. There is no garage, nor any space to build one. The scale is mean and allows no scope for future extension, other

than into the small back garden. Apart from narrow bed for flowers or shrubs along the front of the house, there was no room for any front garden.

The improved visual design submitted recently does not solve the problem of a scale and density that is incompatible with the neighbourhood. Even with the small increase in size, the proposed houses are only 7m wide and are to be built on plots only 8m wide, but the existing semi-detached houses on Delamere Road are 9m wide and are built on plots more than 10m wide. This makes them 25% wider than the proposed houses. The five neighbouring houses on Holmes Chapel Road are on average nearly twice as wide as the proposed houses, with several metres of separation between them. If the proposed houses were of the same scale and density as nearby semis, there would only be room for three houses on the site. That would allow the end house to be a detached house facing Holmes Chapel Road, a much more attractive aspect. Incidentally, the high density housing behind Delamere Road is social housing for disabled people on Chatsworth Drive, built when the Isolation Hospital was closed down. It cannot be described as part of this neighbourhood and is not comparable.

This is a neighbourhood to be proud of; that is why so many residents have taken the trouble to object to this proposal, which would set a precedent for the erosion of an attractive area by speculative developments. The Neighbourhood Plan Housing team has surveyed our estate agents and established that, because of our aging population, bungalows are in high demand. We do not want people buying them up in order to demolish the bungalow and cram the site full of little family houses, of which we already have an adequate supply.
