Sgt. Russel Thomas outlined the key points contained within the PCSO Partner Level Service Agreement and pointed out the vital role that PCSOs play in policing the Town.

It was also pointed out that comparatively speaking, Congleton's anti-social behaviour problems are far less than many other nearby Towns and certainly there are far less night time economy problems.

It was also noted that Cllr P. Bates had spent 2 nights on patrol with a PCSO and that other Councillors intended to take the opportunity to go on patrol with the Police. Concern was expressed at the parking issue around Marfields School and other schools in the area. It was noted that zig zag lines near schools were ineffective and that the Borough Council ought to replace them with double yellow lines.

## NALC Chairman's update on meeting with DCLG Minister

#### To all parish and town councils

Colleagues,

Following my recent emails to parish and town councils about localising council tax support, I wanted to update you on my meeting with the Local Government Minister Brandon Lewis MP last week, where among other issues I kept up the pressure on our call for statutory guidance and transparency over council tax support funding.

The key points of the meeting are below for your information and reference:

- I reminded the Minister of his promise to exert immediate pressure on those billing authorities
  withholding grants as I am still concerned about problems in Swindon and Bromsgrove. It is
  vital you contact your county association if you are also being refused the compensating
  grant.
- at my previous meeting with the Minister in April I continued to press for a share of business
  rates for parish and town councils and last week I followed this up by providing him with a
  range of examples of parish and town councils who are actively leading and supporting
  local economic development in their area. I urged the Minister to consider these examples
  and work with us on measures to incentivise and support further innovative activity.
- we discussed the Local Audit and Accountability Bill and I expressed concerns over auditor
  procurement, outlined our opposition to enshrining in law the publicity code and pressed him
  to use the Bill to reform the rules on parish polls to protect parish and town councils from
  vexatious use wasting tax-payers money.
- I welcomed recent progress on cheque payment reform as this will help our councils save time and money. I am confident this will be resolved in this Parliamentary session and by the Autumn you can start to give your chequebooks a rest!
- although not his direct responsibility, the Minister's Department is still considering how to change the rules to make it easier to set up parish and town councils, and what support people and communities might need. I urged the Minister for progress on this, in particular the introduction of a right of appeal and support package.

While it was a productive meeting, we will continue to keep up the pressure on Government on all the above areas through our political and parliamentary work.

There are a few other issues I want to update you on or draw your attention to:

• I'm following the NALC/All Party Local Democracy Group What next for localism? inquiry with real interest and a wealth of ideas have been submitted so far, on topics ranging from local government finance to councillor training to social media. I would encourage you to have

your say on what's good, bad or ugly about the Government's localism agenda through the **inquiry website**.

- Still on the subject of social media we've expanded how we communicate and engage with our councils and beyond, so please 'like' our <u>Facebook page</u> and 'follow' <u>@NALC on Twitter</u>
- I'm really looking forward to attending and speaking at our three 'Putting Communities First'
  conferences this year, which kick-off in London next month. I hope to see you or there or in
  Sheffield or Bristol, for more information and how to book please visit the <u>event page</u> on our
  website.
- Hot on the heels of January's joint event with the Local Government Association on
  partnership working and devolution of services, we're holding another free event on 23 July,
  this time on the General power of competence. More details will be available shortly, so keep
  an eye on www.nalc.gov.uk and information from your county association.
- Finally I wanted to share with you my delight at the news Government has agreed to <u>extend</u> the Sustainable Communities Act to parish and town councils. This is a real achievement and a direct result of lobbying by NALC, county associations and member councils. It's important not to overlook other lobbying successes in recent months important benefits of your membership so we've developed a <u>short note setting out a few examples</u> where NALC and county associations have worked on your behalf to advocate parish and town councils and bring about change. As Henry Ford once said: "Coming together is a beginning, staying together is progress, and working together is success."

Congleton Town Council Thursday 4 July 2013

Item: Congleton Food and Drink Festival

#### Purpose of the Paper

The Town Council has received many compliments from residents, visitors, traders and publicans about the Food and Drink Festival and Tasty Town week. This paper has been written by the Town Centre and Marketing Manager to thank Congleton Community Projects and the dedicated team of Food and Drink volunteers for organising such a great event in Congleton on Sunday 16 June 2013.

Congleton Community Projects along with a dedicated team of 8 volunteers have organised a Food and Drink Festival in Congleton for the past five years. The 2013 festival was the largest yet with 97 stalls. For the first time Swan Bank and Mill Street were closed to traffic to allow more space for stalls. This proved very successful. The Food and Drink Festival was originally organised for a Sunday as it was the least inconvenient day for shops. Now many shops choose to open on Food and Drink Sunday as it is the busiest day in town — and request that stalls are not placed in front of their shops. This was the reason for the extra road closures

There is no doubt that the Food and Drink Festival is an incredible success and puts Congleton on the Map. It was named as one of the best open air festivals in Cheshire (Cheshire Life). It is hard to judge exact numbers but it would be safe to say visitor numbers were in the region of 10,000-15,000 - with the streets packed from 10.30am -4.30pm.

The festival is a great success because of the passion of the volunteers and Jo Money from Congleton Community Projects. Stalls are chosen carefully and the emphasis is always on localism, quality and traceability. The average mileage for the stalls was just 22 miles and 30% of the stalls were from CW12. Most Food and Drink Festivals are commercial ventures. The Congleton one is respected because it a Community Event with free access. Local trusts help cover marketing and entertainment and the Town Council gives support in kind.

Hundreds of volunteer hours are put into the festival. On the festival day there were around 30 stewards, marshalls and helpers (some representing the Town Council). Many started with clearing the streets at 6.30am and others not finishing until the final litter was picked at 7pm. We are incredibly fortunate to have such dedicated people in the town and it is important that the Town Council continues to support the Food and Drink Festival as well as other groups putting on great events for Congleton – such as Carnival, Jazz and Blues, Arts Festival, Christmas events.

Recommendation: That the Town Council writes a formal thank you to Jo Money at Congleton Community Projects and her team of volunteers for putting on such a successful, well organised and high standard event for Congleton.
