

Buglawton Post Office® is changing

We recently asked your views on some key areas about our plans to change your Post Office to one of our new-look local branches. Although we received no comments about the possible changes, we have now reviewed and finalised our plans for the change to your branch. A summary of some of the main changes for you are provided below.

Your Post Office

You'll be glad to know that most of what you like about your branch won't change. Your new operator is keen to provide the same high standard of service as is currently received and will be trained to the same high Post Office standards.

The changes to your branch

The existing Post Office Counter will be replaced with one of our new style serving positions. You will not notice any other differences and can continue to use the new style counter for most of your products and services.

Your new opening hours

We already have over 2000 branches offering Post Office services in this new way. Feedback from customer satisfaction surveys supports that customers particularly like the longer opening hours the local style branch offers. This means that customers can choose to visit their local branch at times that suit their lifestyle better, whether this be first thing in the morning, during the day, or later in the evening, which also helps to spread customer visits throughout the day.

The availability of Post Office products and services

The new-style local format is a simpler operating model than a traditional style Post Office. It is designed to handle products and services that are automated, meaning that customers can be served quickly and efficiently and transactions processed more quickly. You may need to go to an alternative Post Office for a small number of transactions which are more complex or manual, paper based transactions, like Parcelforce Worldwide International Parcels. But the majority of services will still be available, including the acceptance of Royal Mail international letters, parcels up to 2kg and printed papers up to 5kg.

The small number of services that will no longer be available at Buglawton Post Office will continue to be offered at Congleton Post Office.

Accessing alternative branches during the refurbishment

We've been working with the operator to keep the refurbishment closure to a minimum and a poster is displayed in branch with details of the nearest alternative branches you can use. We're sorry for any inconvenience caused to you during this period.



Re: Parking at Congleton War Memorial Hospital

Thank you for your email dated 7th September with regards to the car parking facilities at the Congleton War Memorial Hospital and please forgive me for the time it has taken to respond to your request for information.

Before answering your questions I would wish to highlight that whilst the Trust Board agreed to introduce parking charges in Congleton the timing of the introduction has been postponed given the current financial position of the Trust and the restriction on expenditure that would need to be incurred before the charging could be implemented.

I will be reporting this to the Trust Board at its next meeting in October.

I can confirm that when charging is introduced:

- there will be clear and visible signage across the site setting out charges and issues
 of non-payment, appeals and payment methods
- ParkingEye is regulated by the BPA (British Parking Association) and conforms to all the rules and regulations of the code of practice
- The first 4 hours will remain free car parking and then any stay above and beyond the first 4 hours will then be chargeable at a tariff to be decided at a later date

At the present time there is no firm date as to when the ParkingEye system will be introduced but I can confirm that there will be a period of publicity to ensure the public are aware.

Dear Town and Parish Councillors,

I am writing to let you know that having signed off the draft Integrated Risk Management Plan (IRMP) 2016/17, the Fire Authority has begun its annual consultation, which will run until 28 December 2015.

The draft plan sets out how the Authority will deliver the most efficient and effective fire and rescue service, while the funding it receives continues to fall by around £2m per year. This includes continuing to implement changes agreed in 2012, as part of our first emergency response programme, which will see the construction of four new fire stations and changes to the way existing stations are staffed.

The latest draft plan also provides more information on the proposed programme of collaboration between Cheshire Fire Authority and Cheshire's Police and Crime Commissioner. If Members agree to the plans, this would create a number of shared support functions and reduce costs by moving to a single, shared headquarters site.

Other headlines projects in the draft Plan include:-

- A review of internal support services not part of the blue light collaboration programme;
- Re-launch our programme of Home Safety Assessments (HSAs) as 'Safe and Well' visits, with firefighters and advocates carrying out additional basic health checks;
- Increase the number of these home safety visits from 20,000 to 40,000 each year;
- Build and launch Safety Central, Cheshire's first dedicated safety centre, at Lymm;
- Work with partners to develop the sub-regional programme to support families and individuals with complex needs;
- · Launch the new fire station at Alsager;
- Build and open new fire stations at Lymm, Penketh and Powey Lane, near the M56;
- Introduce new on-call crewing arrangements for the second fire engines at Crewe and Ellesmere Port;
- Complete a second, comprehensive emergency response review to identify further options to improve the
 efficiency and effectiveness of the organisation's frontline staff and vehicles.

Attached to this email is a copy of our draft Plan and a summary document. I would very much welcome your thoughts and comments on the proposals contained in the draft Plan and encourage you to email any comments to consultation@cheshirefire.gov.uk. Alternatively you can send any written submissions to Freepost Cheshire Fire Consultation. Please ensure that any comments are sent before December 28th 2015.

Once the consultation has closed, Members of the Fire Authority will consider any feedback and make changes before approving a final Plan and Budget in February 2016. The Plan will run from 1 April 2016.

heshire Fire Authority is the public body responsible for ensuring local communities are protected by an effective fire and rescue service.

Over the past few years residents, businesses, partners and staff have all helped the Authority to develop plans so it can continue to deliver that service despite major cuts to its funding.

This summary outlines progress on its existing proposals to transform frontline services as well as a number of new projects planned for the next financial year.

Key proposals include:

- joining up the organisation's back offices with those at Cheshire Constabulary
- transforming the Service's Home Safety Assessments into 'Safe and Well' visits
- launching a pilot project for responding to cardiac incidents in some areas
- delivering annual savings of £2 million a year through efficiencies and limited increases in Council Tax.

Blue Light Collaboration

Cheshire Blue Light Collaboration

Given that major annual cuts to its Government funding are due to continue up to 2020, the Authority is committed to maximising the efficiency of all aspects of the organisation.

There is an ongoing Emergency Response Programme to ensure the most efficient use of frontline services, while options for further efficiencies in emergency response will be the subject of a major public consultation from September 2016.

A previous review of support services has already saved £1.3 million, however, further savings are required and a collaboration project with Cheshire Constabulary is being explored. While each organisation would keep its own identity, frontline emergency response services and governance arrangements, many support services could be delivered by a single team from a shared headquarters site based at the Constabulary's existing Clemonds Hey site in Winsford.

'Safe and Well' visits

The Authority has always regarded prevention as the best way of protecting and improving the safety of local residents. Key to this has been its Home Safety Assessment (HSA) programme which has helped to deliver major improvements in fire safety and contributed to a 29% reduction in incidents attended by the Service over the last five years.

While the Service will continue to focus its HSAs on those most at risk from fire in 2016-17 the Service plans to relaunch them as 'Safe and Well' visits, with firefighters and community safety advocates carrying out additional basic health checks.

These are likely to focus on preventing falls, providing cancer screening information and drug, alcohol and smoking cessation support and referral. In addition, the Service will also support those who have recently been discharged from hospital.

Cardiac response

The Service will also explore a pilot scheme to support the North West Ambulance Service by mobilising its resources as well as theirs to cardiac incidents. If approved the scheme would see both services being mobilised, whoever reaches the casualty first will start providing treatment and once the patient is stabilised they will be taken to hospital by ambulance.

Budget

This Authority's latest financial plans anticipate having to make annual savings of £2million up to 2020. While efficiencies across all aspects of the organisation will make up the bulk of the savings, the budget assumes a 1.99% annual increase in the Authority's Council Tax precept to provide a balanced budget.



Street Cleansing

- 415 bins emptied each week.

- Ruth is still in discussion with Reaseheath College regarding another apprentice to join our team. Closing date for apprentice is 9th November.

John Dwyer Spolice & Crime AND ACTIONS FROM THE COMMISSIONER'S MEETING WITH FARISH COUNCILS & TOWN COUNCILS IN CHESHIRE EAST, 17 SEPTEMBER 2015

The Commissioner announced that his Annual Report for 2014/15 had been distributed to every household in Cheshire during August. Several people in attendance reported that they had not received a copy.

The following issues were raised by the Parish/Town Council representatives in attendance:-

(1) Poynton Town Council – (1) reported that their Town Council part funded PCSOs were being abstracted to police other areas and enquired whether they could fully fund a PCSO which would be dedicated to Poynton; and (2) raised concern about the time taken for their PCSOs to travel back after attending the briefing and not being available to patrol at peak times at the local schools and about the lack of police presence in Poynton, since the new model was introduced.

The Commissioner advised that the Service Level Agreement for PCSOs made provision that if urgent assistance was needed or demand was required, they could be deployed elsewhere e.g. the recent major incident at Bosley. The Commissioner welcomed all suggestions relating to the funding of PCSOs and a number of possible initiatives were being considered with the Chief Constable. The Commissioner added that the FOXI system would enable the Constabulary to monitor an officer's location and provide data on where and how long they spent on patrol or were at a specific incident. In relation to (2) the Commissioner advised that the new model had only been implemented in July and was able to be amended if necessary when the Commissioner and the Chief Constable reviewed it. Town and Parish Councils were encouraged to observe how the implementation of the model progresses and to report any problems that they were experiencing direct to the Commissioner or the Local Policing Unit (LPU) Chief Inspector.

(2) Mottram St. Andrew Parish Council – (1) enquired about the cost of a PCSO and whether two parishes could share the cost of a PCSO; and (2) how does the Parish Council obtain the data from the Speed Indicator Devices?

The Commissioner reported that partners funded a third of the cost of a PCSO (approx. £11,500) with the balance (approx. £23,000) being met from the Commissioner's budget. There was no reason why neighbouring Parish Councils were not able to jointly fund a PCSO. In relation to (2), the Commissioner agreed to bring the matter to the attention of the LPU Chief Inspector.

The Commissioner reported that following the Root & Branch review of the Constabulary, savings had been made which enabled 220 PCSOs to be maintained and as a result of the implementation of the new policing model 130 officers had been redeployed into neighbourhood policing and the recruitment of 53 extra officers by March 2016. The Commissioner added that the Chief Constable wanted every ward within the county to have a

dedicated Beat Manager, Special Constable and PCSO which would improve engagement with local communities and Parish Councils.

Chief Inspector Rob Dickinson's response in relation to (2):Speed Indicator Devices (SID's) that are enabled with data capture can be remotely download by Cheshire East Highways. The data is Cheshire East Highways and the Parish will have to ask Cheshire East Highways for a copy of any data.

(3) Haslington Parish Council – advised that contrary to what the Assistant Chief Constable had reported at the last meeting about a dedicated Special Constable, PCSO and Beat Manager for each ward, that their Beat Manager was responsible for two wards and had been off sick for six months with a broken leg and that the PCSO had also recently resigned.

The Commissioner agreed to raise the issue with the LPU Chief Inspector.

Chief Inspector Gareth Lee's response:I have asked for the local Beat Sergeant to make contact with the Parish Council to understand and address their concerns/provide further information to explain the reasons for their observations.

(4) Alsager Town Council – (1) enquired about the allocation of PCSOs and raised concern about being attached to Crewe, rather than Sandbach which they considered was more aligned in terms of policing issues. (2) Concern was expressed about the lack of consultation by Cheshire East Council on the introduction of a trial Public Space Protection Order in the town. (3) Whether the police still undertook crime prevention work with the Fire Service?

The Commissioner advised that (1) the new model required all officers and PCSOs to book on at one location and be briefed together. This enabled a better quality briefing to be delivered; the opportunity for Sergeants and supervisors to liaise with officers; exchange of information outside the briefings; and being brined as a group raised confidence and was more productive. In relation to (2) the Commissioner advised that he had not been consulted either, however this legislation did provide another tool for the Police to use in reducing crime and anti-social behaviour. (3) Operation Shield was an initiative which comprised of police officers visiting neighbours of a burgled property and distributing crime prevention kits which had resulted in a reduction in the number of burglaries in Cheshire.

(5) Church Lawton Parish Council – advised that (1) they had tried for the past 18 months to get their PCSO to attend a Parish Council meeting with no success; and (2) following a recent traffic survey undertaken by the Highways Department which indicated that motorists were exceeding the speed limit through the village, they now required enforcement action to be undertaken by the Police.

The Commissioner agreed to raise the matters with the LPU Chief Inspector.

I have asked for the local Beat Sergeant to make contact with the Parish Council to understand and address their concerns/provide further information to explain the reasons for their observations.

(6) Moston Parish Council – advised that their PCSO only attended their Parish Council meetings when they coincided within his shift pattern.

The Commissioner advised that shift patterns were flexible and were able to be amended to enable attendance at Parish Council meetings. The matter would be brought to the attention of the LPU Chief Inspector.

Chief Inspector Gareth Lee's response:-

I have asked for the local Beat Sergeant to make contact with the Parish Council to understand and address their concerns/provide further information to explain the reasons for their observations.

(7) Minshull Vernon Parish Council – advised that their PCSO (which was shared with Alsager) travelled around the rural areas in an unmarked vehicle. This caused concern to some residents as it was travelling slowly and could be interpreted as acting suspiciously. The Parish Council considered that a marked police vehicle would act as a better deterrent especially in rural areas.

The Commissioner advised that there were sufficient liveried police vehicles for use by PCSOs and would bring the matter to the attention of the LPU Chief Inspector.

Chief Inspector Gareth Lee's response:-

I have asked for the local Beat Sergeant to make contact with the Parish Council to understand and address their concerns/provide further information to explain the reasons for their observations.

(8) Wilmslow Town Council – reported that since the introduction of the new policing model, their local Police Focus meetings were now very infrequent.

Chief Inspector Rob Dickinson's response:-

Wilmslow held a Police Focus meeting at Wilmslow High School approximately every 3 months. These meetings varied in attendance – usually around 15 people and have evolved into more regular and localised surgeries. At these meetings people are able to raise issues and nominate local priorities.

The surgeries are advertised on the Constabulary's website, in newsletters, tweets, parish noticeboards, shop windows and on local news website.

Should there be a need or appetite for a larger forum then we will revert to a larger building such as a school hall to accommodate the larger audience.

Chief Inspector Dickinson has personally attended meetings with Wilmslow Town Council on 21 September 2015 and at Alderley Edge on 6 July 2015 and will raise this concern with the new Beat Sergeant for Wilmslow, Ange Coppock.

(9) Church Minshull Parish Council – enquired about (1) how the public could find out which officers were assigned to specific wards; and (2) whether the Police should be consulted in the discussions the Parish Council were having with

Cheshire East Council about reducing the 60 mph speed limits on the approaches to the village.

- (1) The Commissioner advised that contact details and information about the police officers and PCSOs was available on the Constabulary's website www.cheshire.police.uk In relation to (2), whilst this was a highways issue, the Parish Council should consult the Constabulary's Roads Policing Support Team and the Traffic Management Officer who is Robin Johnson and can be contacted on 01606 364480.
- (10) Pott Shrigley Parish Council concern was expressed that the 'Neighbourhood Alert' had lost its impetus. It was reported that over a two month period, of the 36 alerts which had been issued, none were of any specific relevance to the Pott Shrigley area and all were county related and contained information of a general nature.

Moston Parish Council and Mottram St Andrew Parish Council raised similar concerns.

The Commissioner agreed to raise the matters with the Head of Engagement.

Martin Bollers, Head of Engagement's response:Cheshire Alert is a valuable communication tool through which the
Constabulary can target information, promote good news and provide
'alerts' to targeted groups of residents anywhere in the county.

We recognise that it is not being used uniformally across the Constabulary; some Local Policing Units (LPU) are better than others in using 'alerts' to regularly communicate with residents and stakeholders. The Constabulary's communications team is working with each LPU to provide training so that a larger pool of officers can use the system. This will enable responsibility for issuing 'alerts' to be spread more equitably. In addition, we will be looking at how we can provide more templates and guidance that will enable local officers to create content more efficiently, improving their take-up.

'Alert' as a system has many advantages, and it is our intention to implement a series of improvements in the New Year, not least the ability to register more easily. We will also be working with LPUs to register those parish councillors and stakeholders not already in the system, to ensure that we have all key individuals in the system.

- (11) Handforth Parish Council enquired (1) whether Cheshire Police would act on evidence obtained from a dashboard camera of a motoring/road traffic offence; (2) whether Cheshire Police would take action against an offender with evidence from a private CCTV camera; and (3) why the Police would not support the Parish Council with the introduction of 20mph speed limits.
 - (1) The Commissioner advised that he would have to seek clarification from the Constabulary on this issue. In relation to (2), the quality of the evidence would need to be clear and the CCTV owners/witnesses would be required to sign statements etc with regard to the authenticity of the evidence and if needed attend court. (3) This was a highways issue and other considerations in addition to Police enforcement such as, changes in road colours/surfaces; structures and signage would also be required.

Chief Inspector Rob Dickinson's response to (1):-

In theory we will try and use evidence based in this way but there are practical difficulties and for these reasons we prefer people to contact us and let us carry out our own investigations. CPS can be reluctant to prosecute as personal equipment is not subject to calibration and the angle of such devices can be misleading, and subject to abuse such as editing etc. There have been occasions when the evidence shown has been a precursor to a road rage incident with fault on both parties and indeed the offending driver has "responded" to a perceived slight in the manner of the driver now making a complaint. Other evidential difficulties can include the use of NIP's, corroboration and the camera car committing offences when trying to keep pace with a speeding vehicle. While we do follow up these issues for the reasons given they are most frequently dealt with by way of advice.

(12) Lower Withington Parish Council – advised that they were in consultation with the Borough Council about reducing the speed limit through the village and enquired which Police department they should liaise with?

The Commissioner agreed to supply contact details to the Parish Council.

Chief Inspector Rob Dickinson's response:-

Enquires such as this should be referred to the Constabulary's Roads Policing Support Team and the Traffic Management Officer.

As a side note, Robin Johnson the Traffic Management Officer did conduct a meeting with Highways in reference to this, however the request had come from Highways and some new limits will be proposed in due course.

(13) Alderley Edge Parish Council – enquired about which agencies they should contact about arranging a road closure for the 'switch on' of the Christmas lights and whether volunteers were able to act as wardens to direct traffic.

The Commissioner advised that approval was required from the local highways authority for temporary road closures for these events. The questioner was directed to contact the Events Safety Advisory Group at Cheshire East Council to pursue the matter further.

(14) Twemlow Parish Council – reported concern about excessive speeding on several 30mph roads in the village.

The concerns have been brought to the attention of the local officer.
