

# Question from Member of the Public - Mr G Goodwin

# Question to the Town Mayor, Cllr D Murphy

In the response to a question provided at the council meeting of 10th July 2014 it was stated that a meeting between one of my Ward Councillors and the Town Clerk was solely to provide advice to my Ward Councillor on the council complaints procedure The response actually said that " the Councillor concerned mentioned that he had been in discussion with you (Graham Goodwin) about the complaint you made against the Town Clerk and asked advice on whether he should declare this matter at the Town Council meeting; he was advised that he should and that was the end of the discussion."

If, as stated, that was "the end of the discussion":-

- why, then, did the Town Clerk consider it necessary or proper to immediately ring the council leader?
- why, within minutes, did the council leader arrive at the Town Hall to discuss the complaint with my Ward Councillor in the presence of the Town Clerk?
- and why, some short time later, did the council leader ring my Ward Councillor, an Independent Councillor, at his home to ask him how he intended to vote even though, at that time, the debate over the complaint had yet to take place

# Response by the Town Mayor

The response to the first two points that you raise is very simple as far as the Town Clerk is concerned.

He is aware that you manage to misinterpret and misconstrue every action taken by him and the Town Council and as such wanted a witness to any information or advice concerning you Mr Goodwin given to Cllr Crowther.

Insofar as the question that you raise relating to Cllr Edwards is concerned again there is a very simple explanation to this.

Cllr Edwards before meeting with Cllr Crowther and the Town Clerk was concerned to ensure that Cllr Crowther was not in a compromised position before meeting him.

Cllr Edwards then during a brief telephone conversation he had with Cllr Crowther prior to meeting with the Town Clerk, asked him if he had decided how he was going to vote on the matter. Cllr Edwards didn't ask him which way he was going to vote, but, asked him if he had decided how.

This was an important question to ask prior to meeting with Cllr Crowther because if the response was that he had already decided how he was going to vote then Cllr Crowther would have been guilty of pre determination and as a consequence neither Cllr Edwards nor the Town Clerk would have been able to meet him or provide any advice on process and procedure.

# Mr G Goodwin asked the following supplementary question

Why would Cllr Edwards ask my Ward Councillor, or any other Councillor for that matter, if they had decided how they were going to vote?

I was clearly under the impression that my Ward Councillor was asked how he intended to vote but, even if the question was had my Councillor decided how he was going to vote, it is, largely immaterial.

The complaint had not yet been heard in Council therefore no Councillor could have made their mind up on either question, so what is Councillor Edwards doing by asking any Councillor, particularly an independent Councillor, if they have made up their mind on how they are going to vote? How could they?

Appeal Ref: APP/R0660/A/14/2212276 – Land Off Newcastle Road, Congleton – The appeal is allowed and planning permission is granted for the erection of up to 9 residential dwellings. Councillor Baxendale informed the meeting that Cheshire East are considering seeking a judicial review.

# 7. HIGHWAYS ISSUES

It was reported that there had recently been traffic congestion due to the road works on West Street. Councillor Baxendale gave an update that this was due to utility works in connection with new housing developments and that Cheshire East had provided information prior to the work starting.

Information was provided on the poor state of the footpaths in Congleton. Examples were given of Buxton Road near St. Stephen's Church, the A34 near Tesco and Rope Walk. Councillors were encouraged up use the Cheshire East Automated System for reporting the specific details. It was agreed that it may be appropriate to discuss this item in more detail at a Community Meeting and arrange for a survey to be conducted. The Town Clerk will be consulted in this respect.

It was reported that there were problems with the route along Wagg Street to Fol Hollow. Information was also provided on traffic turning the wrong way at the junction of Wagg Street and Swan Bank. This will be reported to the Cheshire East Highways Officers.

The meeting was informed of problems at The Vale Walkway and that the street light has still not been repaired.

Councillors requested an update regarding the previously discussed item of cyclists using the pedestrian area and confusion with the signage. The Town Clerk and Cheshire East will be contacted for up to date information.

The site selected is designated in Open Countryside and as such the development fails to comply with this policy and is unacceptable. The applicant also fails to demonstrate clearly that they are exempt from this policy in that this is essential to the local needs and the rural economy

# 2. H6

The planned site is in Open Countryside as indicated in the Congleton Borough Council Local plan and the proposed development fails to comply with any of the categories within this policy

# 3. GR 19

The proposal suggests that the infra-structure present is adequate and no additional improvements or expenditure is required in the immediate vicinity. However, this statement is implausible and contrary to GR19 as the egress from Padgbury Lane to Newcastle Road is very difficult, particularly in the rush hour as the additional traffic emanating from the proposed dwellings would add significantly to this problem, and would place an undue burden on the existing infra-structure at this junction.

### 4. Vehicular Access

The proposal suggests there will be no material traffic impacts associated with the development; however, the Highways Manager stated that by introducing the traffic generation figures from these proposed developments as a cumulative total and by adjusting the distribution pattern to a more realistic level, the highway authority demonstrated that the developments would have a severe impact on a number of junctions along the A34 corridor.

# 5. Local Plan

The Local Plan has been submitted and is now at the examination stage and as such its contents are relevant

The Local Plan designates housing and employment sites to the north of Back Lane and Radnor Park, Padgbury Lane however, is not identified as a strategic site or location
