"The Pearl of the Dane" March Update

I am sure that we are all grateful to Paul Bates, Leo Dene and Joe Henshaw for their public-spirited offer to remove the steam boat and also to the Chronicle for explaining to its readers why Cheshire East cannot demolish it without its owner's permission. Ray Morris has not been answering my phone calls, but according to the Chronicle he is still hoping to sell "The Pearl" as a going concern.

The Environment Agency do not seem to believe that the boat is a flood risk, which is perhaps why they are taking their time dotting all the Is and crossing all the Ts. Stephen Parry told me last week:

"I can confirm that we have been happy with all the design drawings that we have received and we are currently looking at one issue related to the securing bolts. Should this issue be resolved, then we would have no further concerns regarding the potential flood risk of the Pearl of the Dane."

In the meantime there is no visible sign of Ray Morris having started work on its refurbishment.

I would suggest that we consider what action we should take to find out if he is absolutely determined to restore the "Pearl" to her former glory, however much work and expense that entails, or if he would be prepared to give her up given sufficient incentive.

Possible actions are:

- 1. Ask the Cheshire East Planning team to consider using Section 215 of the Town and Country Planning Act 1990 to order the owner of the boat to remove it or restore it to an acceptable condition, on the grounds that it is degrading the amenity of the Town Centre. This action was taken once before. Mr Morris tidied up the boat but then let is deteriorate again. However it is now in a worse condition than it was then, so the labour and expense required to restore it would be greater. Cheshire East would have to be given sufficient time to obey the order, or he would have a reason to appeal against it.
- 2. Ray Morris also owns the nearby Weavers Cottages, which are grade II listed buildings. The state of repair of the woodwork is making them an eye-sore, so a Section 215 order could made in respect of them too, combined with a Section 216 (listed building repair) order.
- 3. We could put forward a proposal to extend the Dane Walkway up to the bridge. This would entail compulsory purchase of the land on which the Pearl stands, and would cost some money, but I believe it would be well spent. It also occurs to me (rightly or wrongly) that a surveyor would not put a high price on that piece of land while it is occupied by a derelict boat. It would also provide the opportunity to create a pleasant place for people to sit by the river.

Investment in Cheshire East's flood defences

Cheshire East Council (CEC) has received £780,000 in funding to improve its flood defences.

The Department for Environment, Food and Rural Affairs (Defra) has awarded the grant to the authority to carry out flood management works over the next five years.

With the funding, the Council plans to install CCTV on all water courses within Cheshire East to monitor flooding.

CEC has identified three sites, worst affected by flooding. Flood alleviation schemes will begin in these areas over the next five years:

- Eaton Village in Macclesfield in 2012;
- Astbury Marsh, Newcastle Road in Congleton, from 2013; and
- Coppice Road/Wistaston Road in Willaston, from 2013.

The flood alleviation schemes will take five years to complete and will be carried out by Cheshire East Council's highways service.

In addition to this, the authority will use some of the funding to improve the water course running parallel to Liverpool Road West in Church Lawton, which has caused flooding in the surrounding area.

The Flood Defence Grant in Aid funding, via Defra, is granted depending on how it will benefit the local community, for example, how many properties are affected by flooding in these areas.

Cheshire East Councillor Rod Menlove, Cabinet member with responsibility for environmental services, said: "I am sure this funding will go a long way to improving flooding in these areas of Cheshire East. I would like to thank Defra for their support and all the officers involved in bidding for this money.

"The affects of climate change show that we will experience increasingly wet weather and we must be prepared for this. These improvements will take time but they will hopefully have a positive impact on alleviating problem flooding for many years to come."

Cellarhead-Macclesfield-Daines Overhead Line Refurbishment

We wrote to you last year to let you know about work being carried out on the overhead electricity line between Cellarhead in Staffordshire, Macclesfield in Cheshire and up to our Daines sub-station, south of Manchester.

To date, we have been replacing some steelwork and security equipment on the towers (pylons). From the last week in March and through the summer, we'll be working to replace the wires between the towers.

We are currently writing to residents and businesses along the route to let them know about the project with the enclosed project leaflet, but wanted to keep you up to date too.

During the works, every effort will be made to keep any disruption to a minimum, especially in residential areas. However, there is likely to be some traffic disruption when we replace the lines that cross roads, particularly when we are working on the towers next to Alderley Edge bypass from 31 May to 21 June when we have agreed with the local authority to close the bypass for safety reasons.

Temporary closures of other roads may require minor diversions or be managed with temporary traffic lights, and there may be some footpath closures in your area too. The safety of local residents, members of the public and our employees remains our highest priority.



The Challenge

The Works

National Grid is planning to refurbish a major overhead power line that runs from Cellarhead in Staffordshire to Macclesfield and on to Daines substation, south of Manchester.


The refurbishment involves replacing the existing conductors (wires) and repairing or renewing the steelwork, foundations and other equipment on some of the towers (pylons).

Initial work has started on replacing sections of steelwork and some of the security equipment on the towers between Cellarhead and Daines,

with further work planned to upgrade steelwork during spring 2012 to those towers between Macclesfield and Henbury.

Between March and October 2012, we will be working on the electricity lines between the towers on all sections of the route. This will involve some traffic management where the lines cross roads, railways and waterways, and detailed plans will be drawn up for all the affected sections ahead of the works.

All work should be complete by the end of 2012.

Your Questions Answered

Q: Will there be local power cuts?

A: No. The work is taking place on the electricity transmission system so local supplies will not be affected. The electricity transmission system operates at high voltages that do not enter homes and businesses – these are supplied at lower voltages by local distribution network operators (DNOs), such as SP Manweb.

Q: What will your working hours be?

A: Our contractors will be working between the hours of 7am and 6pm, Monday to Friday. We may have to work outside of these times depending on how the work is progressing. We'll also be working most weekends throughout the project.

Q: How noisy will the work be?

A: Some of the work that needs to be done will cause some noise, but this should be limited to working hours except in exceptional circumstances. However, we'll do everything we can to keep noise down.

Q: How disruptive will the work be?

A: Our work shouldn't cause a lot of disruption. However, you may see contractors working on the towers and notice a slight increase in traffic movements as equipment and materials are delivered. When we're working on the electricity lines that cross roads, there will be some disruption. However, we'll develop detailed traffic management plans to keep this to a minimum.

We will have to close part of the Bollin Valley Riverside Park near Macclesfield for a short time when we are working on the towers and lines running next to the footpath. We'll put up posters with more information once we know the closure dates. Also, other footpaths and rights of way along the route will be affected when we are working on the overhead lines. The safety of the people using the paths is our prime concern.

When carrying out works such as these, public safety and reducing the disruption to the local community are very important to us. We will do our best to complete this work as quickly as we can.
