

CHESHIRE WEST AND CHESTER LOCAL PLAN

Putting in place a new Local Plan is a key priority for the Council. An up-to-date, adopted Local Plan ensures that planning decisions best reflect locally determined priorities for new homes, jobs, the environment and infrastructure investment. The need to put in place a Local Plan without delay is also coming into sharp focus because of the anticipated revocation of the Regional Strategy for the North West. It is expected to be revoked in the near future which means that its development targets for Cheshire West and Chester urgently need to be replaced with new, locally determined ones that are tailored to meeting the needs of our communities across the borough. Coupled with this is the continued emphasis in national planning policy that planning decision should be plan-led.

In the light of this, the Council's Local Development Framework Panel approved a revised timetable for the preparation of the Local Plan on 28 January 2013, which is summarised below.

I want to highlight that, subject to decisions by councillors; the next opportunity to comment on the Plan will be for six weeks during May and June this year. The specific dates are still to be agreed but will be publicised in advance.

For those of you who have been tracking and commenting on the proposal for Green Belt boundary change around Chester please note that there will be an opportunity for everyone to give their views on any site(s) proposed to be removed from the Green Belt as part of this next consultation. The content of the Plan on this matter is, however, still dependent on the outcome of work currently being carried out into the suitability of various site options. If a Green Belt boundary change is proposed, its inclusion within the full draft plan has the advantage of giving everyone an opportunity to see how it fits into the proposed overall long-term planning strategy both for Chester and for the borough as a whole.
