#### he Town Council is aiming to host a wreath-laying ceremony at the cenotaph on Sunday 8th November with the Congleton branch of the British Legion – but is warning that ONLY those registered to lay a wreath should attend. Everyone else is urged to stay away and join in the two minute silence at home, visiting the new-look cenotaph later in the day or week.

The plan is to work with a local media company to show live footage of the short service via social media, and then to release a copy for Remembrance Day. Road closures and risk assessments have been submitted. If the situation changes, the planned event may need to be cancelled at short notice.

Local people can still support the work of the British Legion by purchasing poppies at the following locations: McColl's West Heath and Buglawton, High Town Post Office, Morrisons, Tesco Barn Road, Visitor Information Centre, Co-op at Bromley Road and schools. After 12th November you can recycle your poppies at Sainsbury's.

Congleton will shine this Christmas with new Christmas lights purchased to brighten up the pedestrian area, Victoria Street, Market Street and West Street and give the town that extra Christmassy glow!

# **Stay Alert to COVID-19**

As numbers of local COVID-19 cases rise, follow Government advice on COVID-19:



#### Wash your hands regularly for 20 seconds or more

- Keep 2m away (or 1m with additional measures) from anyone not in your household or

#### AND DO NOT MEET IN GROUPS **OF MORE THAN 6 PEOPLE.**

Latest figures for COVID-19 in your area can be found online. If you have any of the following symptoms you should get a test and self-isolate with other members of your household:

- A high temperature
- New continuous cough
- Loss of sense of smell or taste

If you are asked by Track and Trace to selfisolate and get a test, you must do so. This is a legal requirement. If you are contacted by someone purporting to be from Track and Trace and you are asked to pay any money, this is a SCAM. Track and Trace will not charge for testing. Speaking Out Against Violence

Congleton Town Council's work on reducing male violence and making more people aware of the need to never commit, excuse or ignore abuse and violence has been recognised nationally. The Town Council is one of around 100 organisations across the UK to be awarded White Ribbon Accreditation.

The Council was awarded the status raising awareness of the issues within the local community including hosting market stalls, awareness training with councillors and

staff and working with Cheshire Without Abuse and Cheshire Police to introduce a monthly Domestic Abuse and Support Clinic in Congleton. In Congleton there is the equivalent of one domestic abuse incident reported daily.

# A Cenotaph Remembering All

Congleton Town Council and the Partnership would like to thank all those who have worked on the new-look Congleton Cenotaph, which now records the names of 590 local service personnel who died serving their country - 239 more than the previous site.

# Policing in the Community

Congleton town is covered by two Safer Neighbourhood Teams.

- Congleton East: PC Helen Weeks and PCSOs Ashleigh Jones and Karen Linton. PCSO David Bell will leave in November to train as a PC.
- · Congleton West: PC Helen Hood, PC lain Bell and PCSOs Ben Hooper and Amy Heath.
- · The surrounding parishes have their own dedicated teams.

The teams will continue to prioritise tackling crime and known anti-social

behaviour in their localities, carrying out targeted operations. Operations and resources are targeted and intelligence driven. You can help by reporting issues in your area via 101, online or by phone. Details about crimes reported in your area can be seen at www.police.uk In August, the four most-reported crimes for both wards were: violence and sexual assault (94 cases), anti-social behaviour (47 cases), public order (32 cases) and criminal damage and arson (19 cases).

# **Bonfire & Firework Safety**

Fire and police chiefs are urging people to take extra care around bonfire night and other festivities and not to put unnecessary strain on blue-light and A&E services.

Usually thousands of people in Congleton congregate at organised public displays to enjoy the safety of professionally organised events. As mass gatherings are currently not possible, there is concern that more people will put on their own garden displays.

If you are planning a small firework display you should....

- Only buy fireworks with the CE mark
- Follow all the instructions to the letter, • including safe distances
- Keep fireworks in a closed box
- Keep naked flames, including cigarettes, away from fireworks
- Do not put fireworks in pockets and never throw them
- Never return to a firework once it's been lit
- Never set off fireworks after 11pm
- Keep pets indoors
  - *Remember the rule of 6 it is illegal for* groups of more than 6 to meet in your house or garden.

# - Creating a More Environmentally-Friendly Congleton

Congleton Town Council declared a climate emergency in September 2019. Initial work has focussed on what the Town Council can do to reduce its carbon footprint. The top 10 areas are being worked on. The group is working closely with Congleton's Sustainability Group to develop an e-learning platform, opportunities for carbon offsetting and creating a town-wide environmental footprint reduction plan. Both Green Fayres planned for 2020 were cancelled, but it is hoped that local podcasts covering key subjects will be launched soon.

# **Working Towards a Plastic Free Congleton**

Plastic Free Congleton remains busy helping Congleton become a Plastic Free Community, an accolade given by the ocean conservation group Surfers Against Sewage. Getting rid of single-use plastics is not an easy task. The

team welcomed the news that single-use plastic straws, cotton buds and stirrers were banned from sale and distribution in the UK earlier this month.

Nine Congleton businesses have now become Plastic

Free Champions and will shortly get their plaques from Plastic Free Congleton. The businesses, which have removed at least three items of single-use plastic from their premises, are: No 1 West Street Hair Salon



(now on High Street), Gather, The Craft Room, The Young Pretender, Wild & Wild, Sugar Plum Hair Salon, Cheshire Brew House, Bare Health and The Old Saw Mill. Three Congleton schools and one nursery have also signed up

to the scheme: Daven Primary, Quinta Primary, Congleton High School, and Friendly Faces day nursery. The community spaces champions are Bromley Farm Community Centre, St. John's Community Centre in

Buglawton, Congleton Museum, and the Cricket and Bowling Club on West Street.

# *30,000 Trees* for Congleton

Around 200 Congleton volunteers have already planted 1,400 trees at 12 sites in and around the town. The Trees for Congleton group has identified a number of sites on which 'to plant' and are busy getting permissions and plans drawn up for trees, hedgerows and new community orchards.

## **Active Travel**

Active Travel is a Community Interest Company which was set up to encourage and enable more people to make more journeys by foot or by bike, recognising the important benefits that this has on individual and community health and wellbeing. The group has developed a dedicated website www.atcongleton.uk where you can find out more and suggest improvements that would make walking or cycling to your destination more achievable. The group is working with the Town Council's Integrated Transport Working Group on initiatives to make it more attractive for people to walk and cycle, including lobbying for 20's Plenty in the town centre and advanced stop lines for cyclists at junctions.





Are you reusing and recycling as much as you could? Cheshire East's recycling rates are above the national average, but more needs to be done! Most households have silver bins. Products in the silver bins should be left loose, not bagged. Many products can be rinsed and placed in your silver bin including:

\*aerosols without lids, \*bubble wrap, \*cans, \*cardboard, \*cartons, \*foil, \*clean aluminium trays, \*fruit & vegetable punnets, \*glass & plastic bottles, \*jars, \*microwave film, \*paper, envelopes and non-glittery wrapping paper and cards, \*polythene, \*soup & sauce pots, \*waxed tea and coffee cups, and yoghurt pots.

# Think Silver, Think Recycling



**Terracycle** sites take products that are more difficult to recycle. There are a number of sites in Congleton that are collecting products that can't go in your silver bin. For example, you can take:

- any brand of bread bag or crisp packet to Buglawton Scout Hut
- soft contact lenses to the Boots store on Bridge Street

# Congleton's Draft Neighbourhood Plan — The Next Steps

The Congleton Neighbourhood Plan team has been working hard to strengthen the town's draft Neighbourhood Plan so that it can reflect the concerns that you shared with us and help the town to develop in the way you wanted it to develop. The draft plan will be out for consultation soon, and we wanted you to know more about it!

# You still have two main roles to play:

- 1. Give us feedback on the plan for the next stage of consultation.
- 2. Vote at a referendum on the plan next year 2021.

Congleton's Neighbourhood Plan has been a long a time in the making, which is largely a reflection on the complexity of the plan. The Congleton Neighbourhood Plan can only consider the geographical area of Congleton Town Council. However, as a plan reflecting the views and needs of the community for the future of the town, the plan cannot ignore the impact that the considerable growth of housing and population in the parishes will have on the town centre. The additional population, estimated to be around 10,000 by 2030, will use Congleton as its key service centre for everyday needs. The draft Neighbourhood Plan, which will be out for consultation later this year, has included policies to reflect this.

The key strands in the 2020 draft Neighbourhood Plan have not radically changed since the earlier version in 2018. The difference is that there is more certainty around the Cheshire East Local Plan, which the Neighbourhood Plan must reflect, and the policies within the plan can echo the stronger environmental policies and guidance which were not in place during the earlier consultation. Government legislation has also changed, and the revised plan reflects these changes. There has also been more evidence gathering to support the local policies.

#### At the core of the plan is:

- Considering the climate change crisis and taking a lead in responding to this.
- Ensuring Congleton thrives economically and socially as an historic market town.
- Protecting and enhancing the town's character, variety of buildings and natural environment.
- Supporting and delivering the facilities and infrastructure that Congleton requires to grow and prosper.
- Maintaining Congleton's strong sense of community as it grows.

#### The process from here:

- 1. A minimum of six weeks' consultation during which national and local organisations with a registered interest and anyone else interested in the plan can comment on the plan (regulation 14). This will be announced on social media and in the press. A full version of the plan will be available at www.mycongleton.org along with all the supporting evidence.
- 2. Time for the Neighbourhood Plan team to consider the comments made and adjust or respond accordingly.
- 3. Congleton will submit the revised draft plan to CEC as the plan that the town would like to take to referendum.
- Cheshire East Council will check that the draft Neighbourhood Plan meets all the basic conditions and is not in conflict with its own policies. CEC will initiate a further round of consultation (Regulation 16).
- 5. Cheshire East will discuss the results of this consultation with the Congleton team.

- 6. The draft plan will be sent to an Independent Planning Inspector for examination. At this stage the Inspector can move the plan to a Public Examination or come back to the team for clarification. The Inspector will remove or modify any policies that cannot be implemented due to uncertainty of how a planning officer would implement them, or because the policy goes beyond national or regional law or guidance.
- 7. If the plan passes the Public Examination with the Planning Inspector, it will be returned to the local authority who will organise a referendum where everyone of voting age and living in Congleton will be asked to say if they accept or reject the plan.
- 8. If approved, the Congleton Neighbourhood Plan will form part of the development plan for Congleton and sit alongside the Local Plan and Site Allocations and Development Policies Document.
- 9. If rejected, developers will still have to meet the polices in Cheshire East's Local Plan, but not the additional direction from the town's plan.

In 2018 the team reached stage 6. After discussions with the Examiner, the team chose to withdraw and amend the plan, as it seemed clear that much of the emphasis that the community had wanted to place on protecting the green spaces and environment policies would be removed due to being unenforceable or going beyond the policy at that time.

#### A summary of the plan:

Creating a Neighbourhood Plan has been a detailed and long process. It started with questionnaires and surveys back in 2015 and along the way has involved numerous workshops, face-to-face meetings and detailed work with sections of the community. The final document is around 70 pages and will be available at **www.mycongleton.org** along with evidence documents. Paper editions of the plan will also be available in the library and Visitor Information Centre when the consultation begins.





# To give you a flavour of the draft plan, the key objectives are:

#### **Climate Change**

- Develop a framework to tackle the growing impacts of climate change on the town.
- Work with the local community to tackle climate change.

#### **Stimulating Local Employment**

- Support existing businesses and promote opportunities for new employment opportunities in the town.
- Work with local schools and businesses to improve the skill base in the town.

#### **Providing for an Ageing Population**

• Encourage the provision of a variety of accommodation in the town to meet the needs of the current and future population including healthcare and leisure facilities.

#### Traffic

- Promote sustainable travel for all residents by provision of new and improved footpaths, bridleways and cycle paths.
- Improve air quality in the town.

#### **Town Centre**

- Regenerate the town centre by making it an attractive, welcoming and interesting area with broad retail, leisure and business offerings.
- Create a place where people wish to visit, work, live, shop, experience the local heritage and be entertained during the daytime and evening.
- Develop and expand the Key Service Centre role of the town.

#### Housing

- Make sure that new housing development is sustainable and meets the needs of existing and future residents.
- Ensure that new housing, commercial buildings, streets and spaces are of a high quality and reflect the established character of the town.

#### **Protecting and Enhancing the Environment**

Congleton is a special place with a variety of green spaces including river and canal corridors as well as access into the surrounding countryside. All new development should protect the current green infrastructure and where possible create new green spaces for the town's residents to enjoy and to fulfil the role of green networks in climate change adaptation.

- The existing green infrastructure should be connected by easy and safe links through and across the town.
- All new development should be carbon-neutral or provide compensation for unavoidable emissions and be encouraged to incorporate renewable energy technology. Retrofitting of older buildings should also be a priority.
- Local food production should be encouraged, including the provision of more allotments on urban sites to correct the current large deficit.
- Natural floodplains and watercourses should be restored when opportunities arise, with no further development on floodplains.

#### Health, Education and Wellbeing

- Ensure that Congleton has health and leisure facilities that are suitable, available, affordable and accessible for everyone in the community.
- Encourage state-of-the-art education facilities for all sections of the community that can support the expanding population of the town and the surrounding area.
- Retention of the existing hospital within the town, particularly as the local population increases.

The Town Council has set aside £20k to support town centre initiatives aimed at helping Congleton businesses. #### **Pubs Working Together to Keep Congleton Safe**

Congleton's pubs are working together to make sure that Congleton can thrive and remain a pleasant place to visit, day or night. At monthly meetings, which are supported by the police and Town Council, the landlords can agree to ban those who are abusive, aggressive or are found to be using or carrying drugs. This ban then applies to all pubs in the group. There are currently 19 people on a Pub Watch Ban. Pub Watch Chair Mick Luke said: "We have many fantastic venues in Congleton, and we are determined to keep it that way. There is no room for drug pushers or rude and aggressive people in our pubs, and we stand united in saying we don't want their business."

# **LINK ROAD**

GRAHAM, the contractor on the Congleton Link Road scheme has made good progress despite challenges in relation to COVID-19 and the inclement weather. GRAHAM has completed the new roundabout on the Sandbach Road as well as the bridge at Giantswood Lane. They have also tarmacked approximately 3.2km of the 5.75km route, with the subbase and structures in place for the rest. Work on the scheme is due to be completed in early 2021 and it is expected to take much of the through traffic currently clogging up the A34 and Clayton by-pass. It is hoped this diversion of through traffic will enable the local community to rethink how best they can navigate a more pedestrian, environmentally and safety friendly Congleton town.

The scheme includes 8 roundabouts, and discussions recently began between Congleton Town Council and the Parishes to design these roundabouts. The intention is to develop designs which will require minimal maintenance.

There is a contract in place for the approved redevelopment of the current site on Hankinson's Field. Cheshire East Council is reviewing all leisure projects during October.
