Retaining current tidy appearance and recreational value, develop a multi-layered vegetation structure with a mosaic of habitats. Improve connectivity with surrounding gardens for greater wildlife benefit.

| Biodiversity evaluation 2022 | Moderate (relative to 30 Congleton sites surveyed) - mature trees are of value. Trend - improving, with the addition of fruit trees and hedgerow. |

| Biodiversity evaluation 2022 | High (floodplain and woodland), low-moderate- the remainder (initial assessment, relative to 30 Congleton sites surveyed). |

Biodiversity aim

Management to protect, restore and expand semi-natural woodland and other existing habitats as well as improving access and interest for users.

| Location | Between Redfern Avenue and Buxton Road, Buglawton. |

| Description | Informal amenity green space consisting of an enclosed wooded valley to the south and grassland to the north. |
| Use | Low-moderate. The footpath connecting Buxton Road and Redfern Avenue is relatively well used despite being largely unsurfaced. The grass and woodland are used for informal play. |
| Total area | 0.59 hectares (1.47 acres) |
| BAP Priority Habitats and Species | Lowland deciduous woodland. Although undesignated much of the woodland is a small remnant of semi-natural ancient woodland. Further survey may possibly identify species of interest. |
| Biodiversity evaluation 2022 | Moderate to high (relative to other urban green spaces surveyed). Trend - static or improving (recent native hedge planting, but damaged by excavation). |
