COUNCIL ITEM 5 URGENT ITEM SECTION 106 23RD JANUARY 2025 1

At our Council meeting in December 2024, I raised the issue of outstanding S106 monies. I can give details of Cheshire East's answers.

Firstly, outstanding monies of £ 800,000 relating to the Thistle Way development, of which £ 540,000 should have been received six years ago and a further £ 255,000 three years ago. The Thistle Way developer, Stewart Milne, went bust in January 2024.

Cheshire East Council confirms that these monies are still outstanding.

This sum of £ 800,000 relates to two separate S106 Agreements signed just 24 hours apart. Cheshire East has given me two completely different answers for these two similar agreements.

For one, Cheshire East Council states the sum of £ 318,805 is outstanding and that, "These (monies) will be pursued without delay. There is no reason why payment will not be received in full from the Developer once reminded of its legal obligations."

This response is factually incorrect because the developer is in Administration.

Regarding the other Agreement. Cheshire East's response states, "We are aware there are monies outstanding totalling £ 481,091 pertaining to (this) planning application. Senior Managers and the Council's Legal Team have been alerted to the situation and will work with the Administrators accordingly."

In my opinion, it is almost certain that this debt is unsecured. In December 2024, Teneo, the Administrator of Stewart Milne advised the Court of Session in Edinburgh that the debts exceeded £ 100 million. Teneo anticipates that only secured creditors will be paid and that hundreds of ordinary creditors, owed over £ 33 million, will not receive any money back. Presumably, to this sum of £ 33 million, we must add Cheshire East Council's debt of £ 800,000, which apparently hasn't even yet been lodged with the Administrator. I fear we must most likely conclude that this £ 800,000 that should have been used for the benefit of our community has been lost. Permanently lost. Truly shocking. Cheshire East have advised me that they are not aware of any other Section 106 overdue and unpaid monies that relate to a Developer in Administration or similar arrangement.

Excluding the Thistle Way Development and the bridge linking Astbury Place with Congleton Park, there is over £ 1 million of Section 106 monies that have not yet been received. Not all this sum is due.

Cheshire East's response states, "The Council has recently introduced a new software system that will assist the S106.... Team to monitor Agreements more effectively. A key priority is to monitor and recover any overdue monies."

This indicates to me that Cheshire East Council admits that it has failed in the past to effectively chase its S106 debts.

Finally, regarding £ 575,000 of S106 monies that have been received and listed as available.

Cheshire East state that we should direct this question to the relevant Service Owner.

A Primary School in Congleton has learnt of my work on S106 monies and asked me to help them obtain some S106 monies towards their future development. Of the \pm 575,000, \pm 168,282 relates to Primary Education.

I have advised this school that the Chief Officer and I must first go through these particular S106 Agreements in detail to ascertain what geographical and specific restrictions (if any) apply.

Furthermore, we need to understand the process Cheshire East Council adopts in ensuring that such monies are paid out in accordance with their Regulations.

If any Councillor is aware of any organisation, such as a school, which could benefit from available funding of S106 monies, then I would be grateful if they could put them in touch with me and we will ascertain what can be achieved to help them.

Hopefully, we can ensure that these available S106 monies can be put to good use for the benefit of our community.
